Team Name: _____ Season: _____ I, the signed player or the parent or legal guardian of a minor player named on this roster, acknowledge, agree and understand that: 1.) Voluntarily and of my own free will, I elect to participate as a member of the softball team indicated. 2.) I understand that there are certain risks and hazards involved in participating in softball including, but not limited to those hazards associated with weather conditions, playing conditions, equipment and other participants in addition to the acts of pitching, throwing, fielding and catching of the ball, the swinging of the bat, running, jumping, stretching, sliding, diving and collisions with other players and with stationary objects, all of which can cause injury. Further, I agree that in consideration for right to play as a member of the team designated below and in consideration for permission to play on the field arranged for by the team or league: 1.) I voluntarily elect or accept and solely assume all risk of damages, injury, including death, incurred or suffered by me (a) while practicing or playing as a member of the team so designated, (b) while serving in a non-playing capacity as a team member or observer during practice or play by other teams or by other players on my team, and (c) while on or upon the premise of any and all of the fields arranged for by my team or league for practice or play. 2.) I release, discharge and agree not to sue the team and/or league designated below or any owner or leasee of fields on which softball is played or practiced by my team or Blue Water Church League, officers, umpires or any person or entity connected with the team, league, field or BWCL for any claim, damages, cost or cause of action which I have or may in the future have as a result of injuries or damages sustained or incurred by me. I am a member in good standing of this softball team and I am eligible to compete with this team. I further agree to abide by the rules and regulations of the BWCL. I also agree not to play for any other men's recreational softball team of any style or speed of pitch. This does not include weekend tournaments but does include all other playoff games, regular season games, or rain make-ups played on weekends. This rule applies to the end of the Blue Water Church League season. Coed and slow-pitch softball will be exempt from this rule. Each player on this team understands that BWCL does not provide medical or liability insurance for the teams or players. Should any team or player suffer any injury during the season, the player is responsible for these injuries and all medical costs. I hereby waive all claims that I might have against the BWCL or the Umpire Assoc. arising out of any injury I may sustain while participating in this league. I further agree to take full responsibility for: (1) any injuries that I may sustain, (2) obtaining health or players insurance, and (3) maintaining the church attendance policy established by the League and my coach.
